Re: **Request under the Freedom of Information Act 5757 - 1998**

1. I am hereby writing you in accordance with the Freedom of Information Act 5758 – 1998 as follows:
2. On May 11, 2014, Directive 3/2011 concerning “the procedure for handling a request for/renewal of an Israeli driving license for a resident of the Area” (hereinafter: **Ministry of Transport procedure**) was annulled, and the Coordinator of Government Activities in the Territories’ “procedure for issuing Palestinian residents of Judea and Samaria and the Gaza Strip a permit for driving an Israeli vehicle“(hereinafter: **the new procedure**) entered into force in its place.
3. We request the following information regarding **2014**:
 - A. How many requests were submitted in 2014 on behalf of Palestinians from the Gaza Strip for a driving license/permit to drive in Israel under the new procedure?
 - B. How many of the overall applicants who submitted requests in 2014 received a permit? For what period of time was each permit given?
 - C. How many of the overall requests submitted in 2014 are still being processed?
