## Decision

1. We have received notice on behalf of the respondents according to which the state agreed to regard the hearing which was held today in the petitions as if an *order nisi* was issued in the petitions.
2. We allow the state, at its request, to submit a complementary notice by November 2, 2015, at 10:00.
3. The state will attach to the complementary notice a detailed list of all demolition orders that as of 2013, this High Court of Justice denied petitions which were filed against them, and that the state failed to execute shortly after the judgments. The details will include: dates of judgments, actual execution dates of the demolition orders and the grounds for the timing of the execution of the orders.
4. The state mentioned in the hearing that it would submit the admissions of the three suspects in the murder of the late Henkin spouses. It will do so in the framework of its complementary notice. To the extent the state wishes to further specify and provide details concerning the evidentiary material in the petitions before us, and particularly in connection with the evidentiary material which pertains to the suspect Ma'ed Salah Jamia Hamed, it will also be able to do so in the framework of the complementary notice.
5. The state will also specify its argument according to which \_\_\_\_ Haj Hamed lived alternately on the two floors in the building being the subject matter of HCJ 7076/15 and in HCJ 7085/15.
6. For the avoidance of any doubt the respondents are requested to specify with respect of the six houses being the subject matter of the proceedings, the petitions which pertain to each and every one of them, and the floor in the building to which the petitions pertain. This is requested for the avoidance of any mistake.
7. The petitioners will be able to respond to the complementary notice on behalf of the state by November 5, 2015, at 10:00.
