Judgment

VERSUS

In view of the notice and statement of the State Representative on behalf of the Respondent, whereby the Respondent will not act to implement the order against the isolated structure object of the demolition order issued pursuant to Regulation 119 (meaning that the order is cancelled) – the petition has been rendered superfluous and is hereby dismissed.

The Respondent claims that there has been a mistake in identifying the terrorist's home, and therefore he reserves the right to issue a new order against the home of the terrorist. Without prejudice to both parties' rights in the matter.

In the circumstances of the case, there is no order as to costs.
