Re: **Application under the Freedom of Information Act 5758-1998 with respect to seizure and demolition orders issued pursuant to Regulation 119 of the Defense (Emergency) Regulations 1945 and orders for the remission of seizures made pursuant to this regulation**

1. I am making the following application under the Freedom of Information Act:

Demolition orders

2. We request information about the number of punitive demolition orders issued by the military in the West Bank and East Jerusalem (separately), beginning in 1967 and up to and including 2015.
3. Please provide the following details for each year separately:
  - a. The number of orders issued
  - b. A geographic breakdown of the orders (by town/village and district)
  - c. Breakdown by type of order (full/partial demolition/sealing).  
With respect to homes that were sealed only, we request information as to whether the military decided on the sealing or whether the sealing was a result of a judicial proceeding. We request details on every house sealed.
4. With respect to demolition orders issued from 2000 onward, we request the date of issuance of each order, and the date of execution.

Remission orders

5. We request information regarding the number of remission requests submitted to the military/minister of defense/home front command, beginning in 1967 and up to and including 2015. Please provide the following details for each year separately:
  - a. The number of applications submitted, along with a geographic breakdown (town/village and district) of the homes.

- b. The number of applications approved, along with a geographic breakdown (town/village and district) of the homes.
6. With respect to applications for remission that were approved, we request to following details regarding each application:
  - a. The date of issuance of the seizure order to which the application refers and the date of the remission order.
  - b. Who submitted the remission application.
  - c. Details regarding the scope of remission: whether the order included full or partial remission, the manner in which remission granted (whether the order granted full or partial use of the land/structure/right to rebuild a demolished property/remove a sealing or any other possible use of the property).
  - d. A geographic breakdown (town/village and district) of approved remission applications.
7. As a non-profit organization working to promote a public objective, HaMoked: Center for the Defence of the Individual is exempt from payment of information application fees. Attached please find, as per legal requirement, the organization's confirmation of proper management.
