We wrote down the State's declaration that in light of the judgment issued in HCJ 7803/06 **Abu** 'Arafeh v. Minister of Interior (13.9.2017), the Minister's decision ordering the revocation of the residency of Petitioners 1-4 should be cancelled, and that the cancellation of the Minister's decision is to enter into effect at the end of six months from the date of the judgment in Abu 'Arafeh.
