**Re: Request for Information regarding Palestinian Administrative Detainees and Unlawful Combatants**

1. I hereby make this application under the Freedom of Information Law, 5758-1998, requesting information on the subject in reference as follows:
  - a. What is the number of **Palestinian administrative detainees** (residents of the West Bank and residents of the Gaza Strip) held in Israeli prisons by virtue of the Order Regarding Security Provisions for a period not exceeding six months? Please provide the information broken down into adult men, adult women, male minors, and female minors.
  - b. What is the number of Palestinian administrative detainees held in Israeli prisons by virtue of the Order Regarding Security Provisions for a period between six months and one year? Please provide the information broken down into adult men, adult women, male minors, and female minors.
  - c. What is the number of Palestinian administrative detainees held in Israeli prisons by virtue of the Order Regarding Security Provisions for a period between one year and two years? Please provide the information broken down into adult men, adult women, male minors, and female minors.
  - d. What is the number of Palestinian administrative detainees held in Israeli prisons by virtue of the Order Regarding Security Provisions for a period exceeding two years? Please provide the information broken down into adult men, adult women, male minors, and female minors.
  - e. What is the number of administrative detainees held by virtue of the Emergency Powers (Detentions) Law, 5739-1979 in Israeli prisons? Please provide the information broken down into adult men, adult women, male minors, and female minors. In addition, please provide a breakdown of the number of detainees held under this law who hold Israeli citizenship as opposed to residents of East Jerusalem with permanent residency.
2. Furthermore, we request information regarding the number of **detainees held under the Incarceration of Unlawful Combatants Law, 5762-2002:**
  - a. How many individuals were held as unlawful combatants in 2024? Please provide the requested information broken down by the duration of incarceration: number held for up to three months; number held for up to six months; number held for over six months.
  - b. We further request that you present this data broken down into adult men, adult women, male minors, and female minors. Please provide this breakdown for each month from September 2023 through the date of response.
3. Please provide the above information as of the date of response.
